#### In the News

- FDA justifies its approval of Dsuvia (sufentanil) sublingual tablets to treat acute pain in selected REMS-certified settings.
- FDA challenge to develop non-opioid devices for pain got > 200 applications for invasive & noninvasive approaches to treating pain.
- ISMP reveals a concerning trend related to the IV opioid shortage is the need to dilute or give partial doses increases the risk for error.
- <u>State-by-state Infographic on opioid-related regulations</u> including required continuing education, medical marijuana laws & more.
- National Academies of Sciences, is tasked with developing a clinical practice guideline on <u>prescribing opioids for acute pain</u>.
- AMA opposes insurer & pharmacist enforcement of CDC opioid prescribing guidelines that supersede clinical judgment & harms patients.
- FDA warns of intrathecal analgesia safety issues like pump failure, dosing errors & using drugs not approved for intrathecal use.
- Concerns expressed about the <u>safety of spinal cord stimulators</u> and other FDA approved devices to treat pain as alternatives to opioids.
- Opioid manufacturers & distributors fight a New York state law demanding \$600 million to recoup costs associated with the opioid crisis.

  25% less pain, better functioning and fewer markers of inflammation than those with a 5% weight loss (who benefitted to a lesser extent).
- Zhu Y, Peng X, Wang S, et al. Vapocoolant spray versus placebo spray/no treatment for reducing pain from intravenous cannulation: A meta-analysis of randomized controlled trials. *Am J Emerg* Med. 2018 Nov;36(11):2085-2092. <u>Vapocoolant spray cuts venipuncture pain</u>.
- Thorn BE, Eyer JC, Van Dyke BP, et al. <u>Literacy-Adapted Cognitive Behavioral Therapy</u> Versus Education for Chronic Pain. *Ann Intern Med*. 2018 Apr 3;168(7):471-480. Literacy-Adapted CBT or simplified group education, helped pain patients in a low-income clinic.
- Caulley L, Caplan B, Ross E. Medical marijuana for chronic pain. *N Engl J Med*. 2018 Oct 18;379(16):1575-1577. Point-counterpoint review of the evidence as applied to a select case of chronic pain. Would you recommend medical marijuana in this case?
- Chen S, Jackson T.Pain beliefs mediate relations between general resilience and dysfunction from chronic back pain. *Rehabil Psychol.* 2018 Nov;63(4):604-611. Further evidence self-efficacy improves coping and catastrophizing contributes to dysfunction.
- Peckham AM, Evoy KE, Ochs L, et al. Gabapentin for off-label use: evidence-based or cause for concern? *Subst Abuse*. 2018 Sep 23;12: 1178221818801311. Gabapentin was aggressively & illegally marketed for numerous off-label uses considered, but rejected by the FDA.
- Song L, Qiu P, Xu J, et al. The effect of combination pharmacotherapy on low back pain: A meta-analysis. Clin J Pain. 2018 Nov;34(11):
   1039-1046.: Despite more side effects, multimodal therapy is best for chronic back pain but increases risk/ benefit ratio for acute back pain.

- Moore RA, Derry S, Wiffen PJ, et al. <u>Estimating relative efficacy in acute postoperative pain</u>: network meta-analysis is consistent with indirect comparison to placebo alone. *Pain*. 2018 Nov;159(11):2234-44. After controlling for placebo effects few differences exist between analgesics
- Fleishman TT, Dreiher J, Shvartman P. Pain in Maintenance Hemodialysis Patients: a multicenter study. *J Pain Symptom Manage*. 2018 Aug;56(2):178-184. Pain afflicts >80% of dialysis patients & is more common in women, sicker patients & those requiring long-term dialysis.
- Sullivan M, Langford DJ, Stitzlein Davies P, et al. Controlled pilot trial of Pain Tracker Self-Manager, a <u>Web-based platform combined with patient coaching, to support patients' self-management</u> of chronic pain *J Pain*. 2018 Sep;19(9):996-1005. Web-based education, outcome tracking & tailored coaching helps chronic pain patients lower pain, disability while enhancing self-efficacy and activity engagement.
- Osborne V, Striley CA, Nixon SJ, et al. Sex differences in patterns of prescription opioid nonmedical use among 10–18 year old in the US.
   Addict Behav. 2018 Oct 9;89:163-171. The <u>prevalence of nonmedical opioid use was 3% American youths</u> between 2008 and 2011. Most got the drugs from school or a family member. Females more frequently got it from a family member and boy snorted the drugs more often.

- The cutting edge of developments in the field of pain are exploring the role of <u>precision medicine to provide more targeted therapies</u>.
- <u>Drug Monitoring in Primary Care</u> provides guidance on monitoring toxicology screening for patients prescribed opioids.

#### **Complementary Integrative Health** (formerly called Complementary Alternative Medicine [CAM])

- More mindful people report less pain and show lower brain activity in key brain regions.
- Mindfulness helps older adults with back pain overcome fear of pain, being more aware & less bothered by pain.
- Prolotherapy injections into rotator cuff can improve pain and function and works longer than steroid injections.
- Pediatric relaxation / mindfulness training & cognitive behavioral therapy is effective for children & teens with migraines.
- Babies had less heel stick pain with maternal holding plus glucose or breastfeeding; than glucose/ breastfeeding alone.
- Holding ice chips in the mouth reduced mucositis pain during fluorouracil-based chemotherapy infusion.
- Aromatherapy during labor is shown to reduce transition pain, without harmful effects, and may shorten labor duration.
